Both parties acknowledge that this mutual understanding and agreement may not be able to contemplate all possible licensing arrangements, technologies or future developments, and therefore both parties agree to cooperate in good faith to achieve the mutual goals of maximizing dissemination of the Author's Contribution while ensuring the sustainability of scholarly publishing.

THE PARTIES HEREBY AGREE ON THE FOLLOWING TERMS AND CONDITIONS OF THE PUBLICATION;

1. COPYRIGHT LICENSE.

The Author(s) grants to PENERBIT ATMA JAYA, a worldwide, royalty-free and exclusive license to:

- (a) Reproduce, publicly display, publicly perform and distribute the Contribution in the Publication;
- (b) Authorize third party users of the Publication in electronic or digital (or other intangible) form to download and print out copies of the Contribution for their personal or internal institutional use;
